Property Taxes for Council Grove City Lake

On May 24, 2016, the District Court of Morris County heard oral arguments based on the Petition of the Plaintiff (Morris County) for Judicial Review of the decision of the Kansas Board of Tax Appeals (BOTA) on the appraisal value of real property at the Council Grove City Lake for tax years 2012 and 2013. The District Court reviewed the record and appeal and considered the arguments presented by the County and the Council Grove City Lake Association (CGCLA) which was empowered by the City of Council Grove to appeal on behalf of the City Lake taxpayers.

In its ruling the Court **affirmed the February, 2015 decision of BOTA and the BOTA order** that the appraisal value for 2012 be set at \$2,366,442 and \$2,386,800 for 2013 instead of the County appraisal of the land \$28,187,810 for 2012 tax year and \$29,871,240 for tax year 2013. The Court also affirmed that the BOTA Finding of Fact was correct in its determination that the County appraisal contained significant *violations* of Uniform Standards of Professional Appraisal Practice (USPAP) and that the County appraisal methodology *violated* Kansas statutes. The Memorandum Decision was filed July 22, 2016 by the Clerk of the Morris County District Court, Case Numbers 2015CV19 and 2015CV18.

Morris County has now filed an appeal with the Kansas Court of Appeals.

The BOTA hearing on the protests for 2014 and 2015 is scheduled for November 3. Morris County commissioners published their intent to appeal to Kansa Court of Appeals in the Council Grove Republican.


