AN ORDINANCE DETERMINING WHEN ONSITE WASTEWATER TREATMENT SYSTEMS MUST BE REPLACED AT THE COUNCIL GROVE LAKE PARK.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COUNCIL GROVE, KANSAS:

Section 1. <u>PURPOSE</u>. This Ordinance is for the purpose of determining when the City of Council Grove will require replacement of an onsite wastewater treatment system installed on property at the Council Grove Lake Park, and shall be construed in conjunction with sections 12-605 through 12-605e inclusive of Ordinance No. 1820 or other ordinances that may hereafter be enacted.

Section 2. <u>ONSITE WASTEWATER TREATMENT SYSTEM COMPONENTS.</u> For the purposes of this ordinance, wastewater system components are:

A. Septic Tank

B. Soil Absorption Field

C. Lift Tank

D. Sanitary Drain Lines

E. Motors and Controls

Section 3. <u>ONSITE WASTEWATER TREATMENT SYSTEM REPAIRS</u>. The following types of repairs are permitted to be made to an existing onsite wastewater treatment system:

A. Replacement of a sanitary drain line between a dwelling and a septic tank or lift station.

B. Replacement of a sanitary drain line between a septic tank and a lift station.

C. Replacement of a sanitary drain line between a septic tank or lift station and the Soil Absorption Field.

D. Installing inlet and outlet tees provided that they are not replacing failed septic tank baffles.

E. Replacement of cracked or damaged septic tank lids.

F. Replacement of aeration motors and/or controls.

G. Replacement of lift pumps and/or valves.

Section 4. <u>ONSITE WASTEWATER TREATMENT SYSTEM REPLACEMENT</u>. If any other component of an onsite wastewater treatment system fails:

A. The Septic Tank shall be replaced with an Advanced Wastewater Treatment System. B. The Soil Absorption Field shall be brought up to current codes for an Advanced

Wastewater Treatment System or replaced in its entirety.

C. An existing septic tank may be converted to a lift tank if it is located more than 100 feet from the lake.

D. All onsite wastewater treatment system replacement activity, whether required by the Ordinance or not, shall be coordinated with and approved by the Morris County Sanitarian and the Council Grove City Inspector.

Section 5. <u>REPEAL</u>. Ordinance No. 2067 is hereby repealed.

Section 6. <u>EFFECTIVE DATE</u>. This ordinance shall take effect upon its publication in the official city newspaper.
